**Sub : Inviting applications for affiliation for the academic year  
2016-17 – reg.**

Applications are invited from the Registered Educational Trusts/ Institutions/ Organisations/ Societies situated in Shimoga & Chikmagalur District areas of Kuvempu University Jurisdiction which are financially viable to start new colleges from the academic year 2016-17 in the discipline of Arts, Science, Commerce & management, Education, Physical Education and B.Voc., degree Courses from the academic year 2016-17, without expecting the state government grant.

Applications are also invited from affiliated colleges of Kuvempu University in the prescribed proforma In duplicate seeking renewal of temporary affiliation for the existing courses; for seeking permanent affiliation for existing temporary affiliation, for extension of degree or Post Graduate degree courses, combinations, languages and for the grant of additional intake of students for the academic year 2016-17.

As the government is planning to introduce online system in conducting affiliation of colleges from the academic year 2016-17, all colleges are once again required to submit their online applications compulsorily, even though the colleges have already submitted their offline applications in duplicate against this notification. In this connection a separate circular will be issued by the University.

The other details are as follows.

01. The application for seeking fresh affiliation to start B.Ed and B.P.Ed colleges can be submitted by registered Educational Trust/ Institutions/Organizations after obtaining prior approval of NCTE or such other authorities strictly following the rules/regulations stipulated by them.
02. The Principals of the existing colleges or registered trust/ institutions/ organisations shall not submit application for affiliation to the courses/optionals for which institution of such courses/optionals are not as per University regulations.
03. The existing colleges that have temporary affiliation for a continuous period of **FIVE** years and have fulfilled the conditions laid down by the Local Inquiry Committee and achieved the academic and administrative standards prescribed by the University and having NAAC accreditation (Minimum 'C' Grade) may submit their application seeking for **permanent affiliation**.
04. The colleges desirous to start Post Graduate programmes can submit application in duplicate for the year 2016-17. Such colleges should have permanent affiliation from the University and should have core faculty consisting of at least four full-time members out of which two must possess Ph.D Degree as prescribed by the UGC. The college in addition to the PG programme should also provide adequate infrastructure facilities for research programmes as stipulated by the UGC/State Government such colleges can submit application in duplicate.
05. While submitting application for seeking fresh affiliation, the registered trust/ Institutions/Organizations should enclose the following documents for consideration, along with the application:

- 1) Copy of the Registration Certificate of the Education Society.
  - 2) Copy of the Memorandum & Articles of Association, Rules, Regulation and Bye-law.
  - 3) In case of a trust, a copy of the Trust Deed and evidence for having registered the same as per rules.
  - 4) Latest Audit Report of the Education Society/Trust.
  - 5) Audit Report of the College.
  - 6) Annual Report of the Previous Year.
  - 7) Place in which proposed college is to be located and its suitability (enclose building plan etc.,)
  - 8) In the case of SC/ST Management, a certificate to that effect, issued by the competent authority.
  - 9) An undertaking stating that the college will comply with all provisions of the Act., Statutes, Regulations, Ordinance, guidelines issued from time to time.
06. The guidelines and regulations pertaining to affiliation issued by the UGC, State Government and University should be strictly adhered to.
07. The Principals of Government Colleges are strictly instructed to get prior approval of the Government to start new courses/subjects/languages and for additional intake, otherwise such requests will not be considered. Further, they are instructed to submit their application furnishing clear information for continuation of affiliation in the prescribed form without fail. In case of additional sections, combinations, languages, increase of intake etc., such requirements should be thoroughly checked and mentioned clearly in the application for sanction of affiliation.
08. 50% concession in affiliation fee will be given to the colleges run by the SC/ST management. Such organizations/trusts should submit a certificate issued by the competent authority stating that their organization/trust belongs to SC/ST Management. Those who fail to submit such certificate, their application will not be considered under 50% concession category.
09. Details of affiliation fees, other instructions and informations will be furnished along with the application. The additional informations can be had from the University website [www.kuvempu.ac.in](http://www.kuvempu.ac.in).
10. Permanently affiliated colleges which are also having temporary affiliation for some degree courses/ optional subjects/ languages shall apply separately for inclusion of those subjects under permanent affiliation.
11. The languages, optional subjects and degree courses other than those mentioned in the application, will not be considered under any circumstances either at the time of LIC visit or at a later stage.
12. Applications may be obtained from the **office of the Director, College Development Council, Kuvempu University, Jnana Sahyadri, Shankaraghatta - 577 451, Shimoga District** by submitting a requisition and paying the prescribed application fee of **Rs.1,815-00 (Rupees one thousand eight hundred fifteen only)** through electronic transfer to Affiliation Account No.54023035811, **State Bank of Mysore, Jnana Sahyadri branch, Shankaraghatta**. The formats of application and challan can be downloaded from the University website and the prescribed application fee may be remitted at the bank.
