Appreciation by KSHCEC

The Principal Secretary, Higher Education welcomed all the IT Coordinators of Universities present in the meeting and enquired about the progress made in respect of ICT initiatives of the Higher Education Department and all the Universities. The following issues were discussed.

- The Chairman expressed happiness about the progress made in ICT initiatives like Office Suite, Online Admission, Audit Para Monitoring System, Court Case monitoring System in the Departments of Collegiate and Technical Education and asked all the VCs to emulate the same in their universities.

Mr. Thangavelu, Technical Director, NIC demonstrated the Online Affiliation system for colleges of all universities and Department of Technical Education. The Chairman asked him to include all parameters based on Local Inspection Committee reports and their comments. The Online Affiliation system should upload the data into a file and sent to Universities / DTE / ED

- The Universities need to upload the questions of all the subjects from the question papers of the last 10 years in the Question bank application developed by NIC. This helps the students to prepare better for exams and it helps the faculty to avoid repetition of questions in the question-papers.

Digitization of Documents like Marks cards, Degree Certificates for online verification - Kuvempu University has implemented this system and the Source code may be shared to NIC to implement for other universities.

- The Chairman directed NIC to make provision for all the faculty to register, get the login and use the applications being developed.

Mr. Thangavelu, Technical Director, NIC explained the e-Payment Gateway system and expressed his readiness to support implementation in transactions like Admission fee, Examination Fee, Revaluation etc

- The chairman insisted all the Universities should install GPS to all the University owned vehicles and the hired vehicles to monitor its usage.

The chairman briefed the registrars that the DCE and DTE have implemented the EMIS and Website Integration for their departments, and the same need to be adopted in the Universities. All the Government, Aided and Private colleges

KUVEMPU UNIVERSITY, JNANA SAHYADRI, SHANKARAGHATTA-577451, SHIVAMOGGA DISTRICT hereinafter referred to as the UNIVERSITY, which expression

shall include wherever the context permits, its assigns and successors-in interest, represented by the Registrar / the Registrar (Evaluation) of the ONE PART.

AND

M/s LOGISYS, BANGALORE, hereinafter referred to as the LOGISYS, which expression shall include wherever the context its assignees and successors-in-interest, represented by its proprietor Sri. H.N. Ramesh (Hutchappa Nandeesh Ramesh) S/o Sri Hutchappa Nandeesh, No.2549, 28th Main, 17th Cross, Banashankari 2nd Stage, Bangalore - 560 070 of the SECOND PART.

WHEREAS the UNIVERSITY has to, inter alia, conduct and supervise examinations for the various Degrees offered by it and being in need of software for the Examination Management System of the UNIVERSITY, has made detailed enquiry with regard to the supply of the said software through e-tendering process.

AND WHEREAS on account of the LOGISYS being shortlisted in the e-tendering process and having already developed software for Examination Management System of University of Mysore, Rajiv Gandhi University of Health Sciences, North-Eastern Hill University-Shillong, Karnataka University, Dharwad, Karnataka State Women's University Bijapur, Cochin Science and technology University, Delhi University and several other universities across the country, the UNIVERSITY decided to take the services of the LOGISYS to process the results on turnkey basis for examinations that is going to be conducted during the period May 2016 - April 2021. The tender evaluation committee that was constituted with the approval of the Hon'ble Vice-Chancellor held a meeting on 11th April 2016 and had discussion with the LOGISYS to arrive at final rate of the said contract that is more favourable to the UNIVERSITY, which is less than the rate quoted in the e-tender. Accordingly, the said contract period was finalised for a period of five academic years with effect from May 2016 examination covering all examinations conducted by the UNIVERSITY.

AND WHEREAS, pursuant to the above, both the parties wish to record hereunder the terms and conditions of the agreement entered into between them in order to facilitate the result declaration process for the UNIVERSITY.

NOW, THEREFORE THIS AGREEMENT WITNESSTH AND THE PARTIES HERETO RECORD HEREUNDER THE SAID TERMS AND CONDITIONS

In consideration of the sum of Rs. 178/- (Rupees one hundred seventy eight only) (inclusive of all applicable taxes as on date) per student per exam/semester to be paid by the UNIVERSITY to the LOGISYS for processing examination results and Rs. 40/- (Rupees forty only) (inclusive of all applicable taxes as on date) to be paid per candidate for convocation related work in the manner provided hereunder, the LOGISYS has

undertaken to process results of all examinations conducted by the UNIVERSITY with effect from May 2016, comprising of the work more fully described as below.

The LOGISYS shall:-

- 1.01 Understand the examination Regulations and accommodate the same into the examination system
- 1.02 Receive answer books at the valuation centers, account for the same, carryout coding / decoding of scripts, manage valuation process, centralized capturing of theory marks. The Logisys shall initiate against thefts, transmission loss , tampering of answer scripts and substitution of answering scripts.
- 1.03 Provide web based modules to capture admission, examination, Practical marks, IA marks, Project Work/Dissertation marks Viva-Voce marks, etc.
- 1.04 There shall also be facility to import the data such as student data, IA Marks data, examination application data, Theory marks data etc to the server form other available soft data copy.

- 1.07 Receipt and maintenance of answer books from examination centers, counting and sorting of answer books based on question paper code, shuffling and coding of answer scripts/preparation of bundles or packets of the coded answer scripts and issue the same to the valuation coordinators.
- 1.08 Appearing Statement (centre wise list of students appearing for a paper)
- 1.09 Generate one set of University result, college result, one set of ledger for calico binding and print Marks Cards with covering letter to College/Department/Study Centers
- 1.10 Generation and Printing of Provisional Pass Certificate
- 1.11 Announcement of result on Internet Generation of all mandatory reports such as Marks Ledger (bounded), Result Sheet, Rank List, Statistical Reports, etc.
- 1.12 Convocation process: To carryout end to end activities of convocation related work such as online convocation application processing, degree certificate printing and any other work as assigned by the university. Printing of Convocation Certificate on the secured stationary provided by University along with photo and other related convocation works.

- 1.13 Generation of Eligibility list of candidates for Convocation, List of Rank holders, List of Eligible candidates for Gold Medal and Cash award and printing of Degree certificate, Rank Certificate, Gold Medal Certificate, Cash prize Certificate and Convocation Ledgers with Photo of Students
- 1.14 To support in Photo-copying, Revaluation/ Re-totaling / Challenge Valuation / Board valuation / 3rd valuation/ such as pulling out Answer scripts / masking of marks /coding / entry of revaluation marks/ generation of 3rd valuation report.
- 1.15 Preparing data for next examination after updating the results announced later and incorporating the Revaluation/Re-totaling/Challenge Valuation results & also hosting on internet.
- 1.16 If the student applies for old corrections such as NCL removal/correction of mark card/consolidation of Mark Card/Duplicate Marks Card/Duplicate PPC/Duplicate Degree Certificate/Transcript which was generated by earlier software, then M/s Logisys should be able to prepare and print those Mark Card/Statement etc., using their software.
- 1.17 M/s Logisys should keep a Copy of complete working software database along with the all necessary supporting software's in a bank locker at the cost of M/s Logisys and University may use it in the future if required.
- 1.18 Legacy data to be converted from the year 1999 till date to support the above said activity.
- 1.19 Tracking and mapping of Marks card with Registration number.
- 1.20 Handling of Ph. D. Course work Examinations.
- 1.21 Shall arrange for the stationary / consumables that are required for coding and valuation and other purpose.
- 1.22 Provide technical support for all examinations conducted by the UNIVERSITY effective from May 2016 for a period of five years.
- 1.23 Shall be solely responsible for the accurate announcement of results
- 1.24 Shall prepare a Schedule of Activities for each Semester (examination cycle) in consultation with the Registrar (Evaluation) and his team and implement the plan in letter & spirit.
- 1.25 Shall submit necessary data in the required, structured format with latest version of SQL/Mdb/MS Excel as required by the University as regularly (monthly) to the University/Government so as to reconstruct the database.

- 1.26 M/s Logisys shall also periodically update the software and the database in the server provided by the University situated in the Office of the Registrar (Evaluation) without fail.
- 1.27 If the M/s Logisys waste any stationery, such as Marks card, PPC and Degree Certificate provided by the University then the M/s Logisys will bear the actual of cost of wasted materials to the University.
- 1.28 The LOGISYS at their expense shall arrange the required number of personnel with proven competency in handling computers and confidential matters and a exclusive project manager to execute the work. The project manager is responsible and for decision making on behalf of the LOGISYS in all Examination work and for keeping confidentiality in all matters covered under this contract. The project manager shall correspond with the University Registrar (Evaluation) in day to day examination work.

2 The UNIVERSITY shall:

- 2.01 Provide Regulations and guidelines of all the courses
- 2.02 Provide working space with computers, UPS and Printers
- 2.03 Provide working space for about 30 personnel that include tables, chairs etc.,
- 2.04 Provide storing space for safe keeping of records.
- 2.05 Depute one senior official to monitor the work on a continuous basis. This official shall be responsible for decision making on behalf of the UNIVERSITY in all examination related work and shall communicate with the LOGISYS's nodal officer in written mode only. This official shall also be responsible to ascertain bonafide of the student and also student's particulars such as college, student's name and other particulars prior to announcement of result.
- 2.06 Confirm the eligibility of students and Regulations adopted in the software for result processing before announcing the same.
- 2.07 The correctness of the course Regulations, gracing rules and other parameters adopted for processing the results. This should be done before announcing the results.

- 5.19 Provision to obtain their results in internet and upon request through SMS.
- 5.20 To make provision for Colleges /Study centers/ P.G Department to download the results sheets / ledgers immediately after the announcement of results.
- 5.21 To make provision for students to apply for RV / RT / CV / Photocopy through online. Fee payment is made through various modes such as Bank, Post-office, Credit Card, Debit Card, etc.
- 5.22 To provide help desk for all colleges / students

6. Module that will form the system:

- 6.1 Reference: Degree, Subject, College, Student, Reason, and Mapping of subjects.
- 6.2 Before Examination: Generating Register Numbers of fresh candidates, Activating examination for all students, Activating examination for any given student, Generating Application / Admission forms, identifying eligible students, exam wise student ledger, Subjects, Question Paper requirement, Centre wise Question Paper requirement, Generation of Register number sticker, Code number sticker, Marks sheet.
- 6.3 Shall train such staff members of the University, that may be identified by the University from time to time during the tenure of this agreement for handling the software.
- 6.4 Tabulation: Updating Absent particulars, Generation of coded numbers, Updating marks, Updating withheld, MP details, Student wise packet listing, Checklist generation for absent / marks, Marks not entered listing.
- 6.5 Result computation: Computation of result for all students

- 6.6 Reports / Statements: Final Result statement, Marks Cards, Covering letter for marks card, Marks Register, Eligibility statement, Group wise / College wise result analysis, Rank statement, Provisional degree certificate, Degree Certificate, Consolidated and Duplicate Marks Cards, Exam wise, student fail listing, Subject wise, highest marks listing.
- 6.7 Closing of examination: For all students, Closing of examination for a given student, Preparing data for next examination for all students after updating the Results announced later and the Revaluation / Re-totaling results. Preparing data for next examination for a given student.
- 6.8 Utilities: Defining access level for different users, Indexing of data files, viewing of spooled reports, Tabulation error listing, Resetting of Tabulation error data, provision for result modification with strict audit trail, revaluation, re-totaling, etc.

7. Statistical Reports

- 7.1 Criteria check for Gracing Policies, Verification and other relevant checks to generate Reports as required for Academic year
- 7.2 Generation of Rank List for graduation candidates for the year, Candidates Rank List Stream-wise, Eligible Candidates List for Convocation.
- 7.3 Transfer Statistical Data to for the Convocation Diary Creation.
- 7.4 Facilitate University by transferring existing Statistical Reports that may further be used for the compilation of Convocation Diary. University will compile and prepare the Convocation Diary.
- 7.5 Submitting college-wise, course-wise ledger for binding and certification for each semester.

8. Financials:

- 8.1 The consideration of the sum of Rs. 40/- (Rupees forty only) (rate inclusive of all applicable taxes as on date) per candidate shall be paid for convocation related work. The consideration of the sum of Rs.178/- (Rupees one hundred seventy eight only) per student per exam/semester (rate inclusive of all applicable taxes as on date) shall be paid by the UNIVERSITY to the LOGISYS for each exam separately as hereunder:
- 8.2 The University shall effect TDS for the payments that the University makes under the subject contract.
- 8.3 1st payment - 40% of the total consideration of the result processing amount shall be paid by the UNIVERSITY to the LOGISYS on completion of 75% of coding process of the examination in consideration.

- 8.4 2nd payment - 50% of the total consideration of the result processing amount shall be paid by the UNIVERSITY to the LOGISYS immediately after declaring 75% of the scheduled results of the examination in consideration.
- 8.5 3rd payment - Total amount of the project shall be arrived @ Rs. 178/- (Rupees one hundred seventy eight only) (rate inclusive of all applicable taxes as on date) per student per exam/semester by considering actual no. of students registered for the examination in consideration. 3rd payment shall be made by the UNIVERSITY to the LOGISYS after deducting the payment made under 1st and 2nd installment. 'Confidential Information' includes, information relating to released or unreleased Disclosing Party's services or products, the marketing or promotion of any Disclosing Party Product, Disclosing Party's business policy Confidential Information or practices, and information received from other that Disclosing Party is obligated to treat as confidential or in respect of the Internet Payment Gateway.

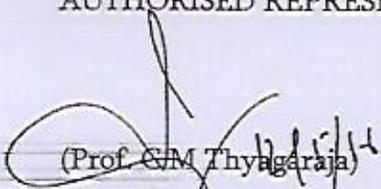

KUVEMPU UNIVERSITY, JNANA SAHYADRI, SHANKARAGHATTA-577451, SHIVAMOGGA DISTRICT hereinafter referred to as the UNIVERSITY, which expression

shall include wherever the context permits, its assigns and successors-in interest, represented by the Registrar / the Registrar (Evaluation) of the ONE PART.

AND

M/s LOGISYS, BENGALURU, hereinafter referred to as the LOGISYS, which expression shall include wherever the context its assignees and successors-in-interest, represented by its proprietor Sri. H.N. Ramesh (Hutchappa Nandeesh Ramesh) S/o Sri Hutchappa Nandeesh, No.2549, 28th Main, 17th Cross, Banashankari 2nd Stage, Bengaluru - 560 070 of the SECOND PART.

WHEREAS the UNIVERSITY has to, inter alia, conduct and supervise examinations for the various Degrees offered by it and being in need of software for the Examination Management System of the UNIVERSITY, has entered into an agreement with LOGISYS to provide such service software through e-tendering process.

In the agreement dated 12th May 2016, the contract was awarded for a consideration of the sum of Rs. 178/- (Rupees one hundred seventy eight only) (inclusive of all applicable taxes as on date) per student per exam/semester to be paid by the UNIVERSITY to the LOGISYS for processing examination results and Rs. 40/- (Rupees forty only) (inclusive of all applicable taxes as on date) to be paid per candidate for convocation related work. The contract also provided an annual increase of 5% over the previous year's price.

WHEREAS LOGISYS submitted the bills for work completed without claiming any tax till 31st March 2017 as per the agreement. The work that being done by LOGISYS for UNIVERSITY was exempted from Service Tax till 31st March 2017 and the Govt. of India in its notification having reference number 10/2017 dated 8th March 2017 restricted this exemption only upto Higher Secondary school or equivalent, due to which, the service tax of 15% was made applicable on the work that was carried out by LOGISYS for UNIVERISTY.

WHEREAS the Govt. of India introduced Goods and Service Tax (GST) across the country with effect from 1st July 2017 and as per the notification, the service tax that existed till 30th June 2017 became part of GST. As per the government notification, GST at the rate of 18% will be applicable on the nature of work that is being carried out by LOGISYS for UNIVERSITY.

WHEREAS LOGISYS had submitted two letters dated 28th March 2017 and 24th July 2017 requesting the UNIVERSITY to pay this tax component that came into existence due to change in policy of Govt. of India. The request was then referred to the UNIVERSITY Chartered Accountant upon approval of Vice-Chancellor for opinion.


Registrar (Evaluation)

WHEREAS the UNIVERSITY Chartered Accountant after detailed and careful analysis of all the issues concerned, has given his opinion through a letter dated 12th August 2017 which states as "In my opinion, in the changed scenario, due to change in the law, UNIVERSITY has to pay the applicable Service Tax / GST to M/s LOGISYS"

WHEREAS the UNIVERSITY Chartered Accountant also had given suggestion that the UNIVERSITY by keeping clause (14) of the agreement dated 12th May 2016 to have a meeting with service provider - i.e., M/s LOGISYS for taking appropriate commercial decision

WHEREAS a meeting was held between the Hon'ble Vice-Chancellor and Sri. H N Ramesh, CEO of M/s Logisys in presence of the Registrar (Evaluation) - Prof. Raja Naika and it was resolved to accept the recommendation made by the UNIVERSITY Chartered Accountant in paying Service Tax / GST component to LOGISYS for all the bills that were / will be submitted on or after 1st April 2017. As the taxation rate was ZERO on the date of signing of agreement dated 12th May 2016 and in order to have clear clarity for all future payments, it was further resolved and agreed to make correction to the agreement dated 12th May 2016 wherein the words "inclusive of all applicable taxes as on date" shall be replaced by "and applicable taxes"

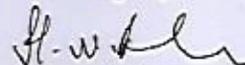
All other terms and conditions with regards to the nature of work being carried out by LOGISYS will continue to remain as per the agreement dated 12th May 2016.

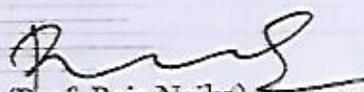
