## **Ph.D. Entrance Test Result – Nov 2025**

### ***Important Note***

1. The minimum marks for pass in Ph.D. Entrance Test is 50% of the total Marks (i.e., 45 Marks out of 90 Marks) with a relaxation of 5% to SC/ST/OBC (noncreamy layer)/differently abled category candidates (i.e., 40 Marks out of 90 Marks).
2. There is no minimum pass marks for the candidates who have qualified UGC/CSIR-NET (including Lectureship/SLET/GATE/Teacher Fellowship holder/Inspire Fellowships). However, the marks secured in the Ph.D. Entrance Test shall be the basis for the preparation of merit list.
3. The eligible candidates as per the above note are required to attend the Ph.D. Entrance Test Viva-Voce Examination on **16-12-2025 (Tuesday) at 11.30 AM** in the Dept of Industrial Chemistry, Jnanasahyadri, Chemical Sciences Block, Kuvempu, University, Shankaraghatta-577 451, Shimoga
