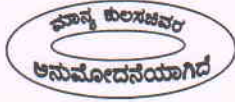

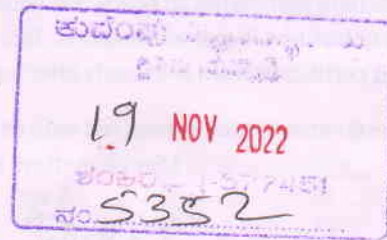

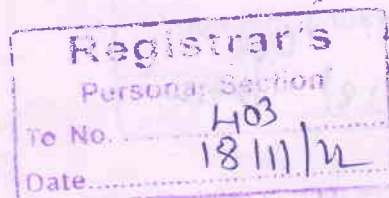

## Faculty Training Proposal for "Artificial Intelligence" course by NASSCOM and MICROSOFT

### Highlights of the training

1. FDP to be launched on the mutually agreed dates.
2. All programs to be completed by 15, December 2022.
3. Each program is of 18-hour duration conducted as under:

Day 01	04 hours	Online, Supervised by Microsoft and NASSCOM	This is an online session. Participants may attend from their respective places.
Day 02	08 hours	In person, by Microsoft and NASSCOM	This is an in-person session at a common venue decided by university.
Day 03 & Day 04	08 hours	Online, self-paced	This is an online session. Participants may attend from their respective places.

### Role of University

1. Notify the course as core course to be taught in II year UG degree program (3<sup>rd</sup> Sem / 4<sup>th</sup> Sem). BoS to prepare the assessment plan including formative assessment and term end assessment.
2. Identify one faculty member from the University as **Coordinator** for this course. Coordinator will report to Registrar and liaison between NASSCOM, KSHEC, Colleges and University for smooth delivery of the course on "Artificial Intelligence". Communicate the name, mobile no and email\_id of Coordinator to [jayappam@kshec.ac.in](mailto:jayappam@kshec.ac.in) latest by June 20,2022.
3. Coordinator is to finalise the FDP dates (Date for Day 01 – Online, and Date for Day 02- in person) in consultation with Prof. Jayappa, Special Officer, KSHEC. Venue for the in-person also needs to be finalised by the University. The expenditure involved in hosting the FDPs be borne by the respective Universities.
4. Notify information about the FDP to all affiliated colleges and collect nominations for teaching this course (two per College) and coordinator to prepare the list of participants in the format ( name of teacher, college, email\_id, mobile no).
5. Teachers nominated to teach this course are expected to complete the entire course attending both online and in-person sessions. This course has a certification exam which entitles the teachers to get certificate from Microsoft after successful completion of the course and clearing the exam.
